- (h). PRESENT AND DISCUSS THE MOST SUITABLE TOOLS AND METHODOLOGIES FOR AFRICA DRAWING FROM THE GENERAL ASSESSMENT AND THE ETHIOPIA CASE STUDY

 (j). PREPARE AND SUBMIT FOR PEER REVIEW A ROBUST ANALYTICAL DRAFT REPORT ON TOOLS AND METHODOLOGIES FOR INCLUSIVE GREEN ECONOMY POLICIES IN AFRICA THAT AMONG OTHER THINGS, SHOWCASES THE ETHIOPIA SPECIFIC ASSESSMENT. THE REPORT SHOULD COVER, BUT NOT BE LIMITED TO THE ISSUES IDENTIFIED IN (a) TO (i).



DISCUSSION OUTCOMES AND RECOMMENDATION



GENERALLY RESPONSIVE TO THE TOR (STRENGTHS)



- SUPPLEMENTED THE DOCUMENTARY REVIEW WITH QUESTIONNAIRE TO ASSESS :
- 1. THE IA TOOLS AND METHODOLOGIES EMPLOYED IN THE COURSE OF FORMULATING THE STRATEGY
- 2. THE RELIABILITY AND APPROPRIATENESS OF DATA AND INDICATORS USED

GENERALLY RESPONSIVE TO THE TOR (STRENGTHS)

 ADOPTED PARICIPATORY APPROACH IN THE ETHIOPIAN CASE STUDY: CONSULTED VARIOUS MINISTRIES AND RESEARCH INSTITUTES





HOWEVER (WEAKNESSES)

- DESCRIPTION OF THE CRGE IS TOO BRIEF AND DOES NOT BRING OUT THE KEY FEATURES OF THE CRGE AS A GREEN ECONOMY STRATEGY IN A WAY TO DRAW LESSONS FOR OTHER AFRICAN COUNTRIES
- THE CASE STUDY COULD NOT CLEARLY IDENTIFY THE BEST PRACTICES AND/OR THE DRAWBACKS IN THE ETHIOPIAN CASE WHICH CAN PROVIDE PRACTICAL LESSONS FOR OTHER AFRICAN COUNTRIES
- ANALYSIS OF TOOLS AND METHODOLOGY FOR THE POLICY CYCLE WAS INADEQUATE eg. BASED ON INFORMATION FROM INDIVIDUALS, ALSO BY SAYING "SCENARIO CREATION TOOLS WERE USED TO ANAYLSE POTENTIAL DEVELOPMENT IN DIFFERENT SECTORS", THE TYPE OF TOOLS WERE NOT ANALYSED/INDICATED THROUHOUT THE POLICY CYCLE

HOWEVER (WEAKNESSES)

- THE STRENGTHS AND WEAKNESSES OF THE TOOLS AND METHODOLOGIES USED IN THE CASE STUDY WERE NOT CLEARLY ANALYSED eg. What went well and what did not go well or what could have been done
- THERE WAS NO CLEAR LINKAGE BETWEEN THE REVIEW (THEORY) AND THE CASE STUDY (PRACTICE)
- THE ORIGINAL CRGE DOCUMENT PROVIDES DETAILED INFORMATION ON THE TOOLS AND METHODOLOGY USED, BUT THEY ARE NOT REFLECTED AND EVALUATED IN THE CONSULTANT'S REPORT TO GIVE OTHER AFRICAN COUNTRIES OPPORTUNITIES TO LEARN



HOWEVER (WEAKNESSES)



- THE INSTITIONAL AND ADMINISTRATIVE CONTEXT OF ETHIOPIA WAS NOT ADEQUATELY ANALYSED FOR RELEVANT LESSONS FOR AFRICA.(INCLUDING THE LEGAL FRAMEWORK, DECENTRALIZATION, ETC) (*NB. UNECA,* 2012, HAS INDICATED THAT EQUAL EMPHASIS SHOULD BE GIVEN TO GOVERNANCE AND INSTITUTIONS)
- THE QUESTIONNAIRE DID NOT COVER THE PRIVATE SECTOR AND CIVIC SOCIETY

KEY MESSAGES

- POLITICAL SUPPORT/COMMITMENT AT THE HIGHEST LEVEL IS CRITICAL FOR SUCCESSFUL DEVELOPMENT AND IMPLIMENTATION OF IGE STRATEGIES
- CAPACITY BUILDING IS REQUIRED FOR ALL DECISION MAKERS AND TECHNICAL STAFF AT ALL LEVELS OF GOVERNMENT AND FOR ALL STAKEHOLDERS IN THE DEVELOPMENT AND IMPLEMENTATION OF IGE STRATEGIES.
- RELIABLE AND TIMELY DATA ARE ESSENTIAL IN THE DEVELOPMENT AND APPLICATION OF IA TOOLS AND METHODOLOGY



SPECIFIC COMMENTS/GAPS & FACTUAL ERRORS



- SOME INSTITUTIONS HAVE NOT RECEIVED THE QUESTIONNAIRES (eg MEF) WHILE OTHERS HAVE RECEIVED THE QUESTIONNAIRE BUT HAVE NOT RESPONDED, THEREFORE THE RESULTS CANNOT BE CONCLUSIVE
- IT IS NOT CLEAR WHETHER OR NOT THE RESPONSES FROM THE INSTITUTIONS ARE REPRESENTATIVE OF INSTITUTION'S EXPERIENCE OR THOSE OF INDIVIDUALS
- MISSED INFORMATION ON ON-GOING WORK ON INTEGRATED TOOLS DEVELOPMENT IN THE COUNTRY (MOFED/MI) INVOLVING 7 MINISTRIES TOWARDS THE IMPLEMENTATION OF CRGE (T21 MODEL)

SPECIFIC COMMENTS/GAPS & FACTUAL ERRORS

 UPDATED VERSION OF THE CRGE DOCUMENT IS AVAILABLE BUT NOT REVIEWED (eg. PILLARS 1,3, AND 4 HAVE BEEN REVISED:

 PILLAR 1: IMPROVING CROP AND LIVESTOCK PRODUCTION PRACTICES FOR HIGHER FOOD SECURITY AND FARMER INCOME WHILE REDUCING EMISSIONS



ADDITIONAL DATA/INFORMATION

 SOURCES OF DATA NOT FULLY EXPLOITED (WITH RESPECT TO ENVIRONMENT STATISTICS, SECONDARY DAY EXIST IN PUBLICATIONS ,REPORTS FROM MINISTRIES, RESEARCH INSTITUTIONS ETC)



WAY FORWARD

- CONSIDER THE COMMENTS AND FEEDBACK FROM THE EGM TO REVISE AND ENRICH THE DOCUMENT, IN PARTICULAR, THE IA TOOLS AND METHODOLOGIES SHOULD BE CLEARLY IDENTIFIED AND THE STRENTHGS AND WEAKNESSES EXPLAINED WITH ILLUSTRATIONS FROM THE ETHIOPIAN CASE CASE STUDY
- THE REVISED DOCUMENT SHOULD BE COMMUNICATED TO THE PARTICIPANTS FOR VALIDATION AS APPROPRIATE
