# 4. Levels and trends of support for statistical development in Africa

This session will include a presentation of overall partner support based on the PARIS21 PRESS report, and an analysis of the support levels and trends. It will also include presentations on specific programmes or initiatives in selected countries with a special focus on the achievements of the programmes, not just on the implementation processes. The reports and presentations will focus on results. The Chair will allow interventions from the floor (not more than three minutes) on some of the programmes.

## 6. Making partner support more effective and efficient

This session will deal with modalities of financing statistical development and implementing National Strategies for the Development of Statistics, the application of the Paris Declaration on Aid Effectiveness principles to support statistics, architecture for supporting statistical development in Africa, donor coordination under the Statistics for Results Facility, coordination of support for statistical development among international organizations, and the role of partners in fostering South-South cooperation.
