Information note for participants



The Building back better: Planning workshop for climate resilient investment in reconstruction and development in cyclone affected regions of Malawi, Mozambique and Zimbabwe meeting will take place in Harare, from 23-25 October 2019. The venue will be the *Rainbow Towers Hotel & Conference Centre*.

All sponsored international and national participants outside from Harare area are required to stay at the conference venue.



Please read the following information carefully, as it will help you to plan your travel to Harare.

Hotel accommodation

All sponsored Non-Harare based local and international participants are accommodated at the venue of the workshop; Rainbow Towers Hotel & Conference Centre on a single occupancy with bed and breakfast basis for a standard room.

However, participants are responsible in settling their bills directly with the hotel. The UN discounted rate that only applies for the workshop participants is **USD 80.00** inclusive of all taxes and tariffs.

In addition to accommodation costs, participants are responsible for all other additional expenses – such as, telephone, Internet/fax, room service, mini-bar, laundry, other meals and must settle their bills directly with the hotel when checking out.

It is important to note that the accommodation expense will be deducted from the applicable Daily subsistence allowance of sponsored participants regardless of their stay at the designated hotel or not. Therefore, we encourage sponsored participants to stay at the designated hotel.



Daily Subsistence Allowance

Sponsored participants will receive the applicable subsistence allowance for accommodation, meal and other incidental expenses according to the UN subsistence allowance rule by the UN designated financial institute prior to the end of the workshop.

Exact date and time will be communicated in due time.

Airport Transfer

Shuttle services are available by Rainbow Towers hotel and conference at a charge of USD **10.00/person** if booked in advance for **a group** shuttle. Participants can register their arrival time and flight number through <u>https://www.uneca.org/acpc-common/itinerary-information</u> and pay directly to the service provider.

Taxis are also available at the arrival terminal. Kindly note that participants who will not stay at the venue will be responsible for their own daily transportation to and from the venue.

Immigration requirements

All participants attending the meeting can obtain business visas on arrival at Robert Gabriel Mugabe International Airport, Harare, where they will be required to produce and present their invitation letter to the immigration authorities. Thus, kindly ensure you print and bring with you this letter.

Please note that the current charge for a single entry Zimbabwe visa issued on arrival is US\$ 30 and US\$ 45 for a double entry, although this could change at any stage Holders of diplomatic and service passports and United Nations Laissez-Passer (UNLP) will receive visas gratis on arrival.

Guidelines on the personal security and safety of participants

While you are on the conference center, please ensure that you:

- Wear your conference badge visibly and show it to any authorized person who asks to see it.
- Do not leave bags and parcels unattended, as they may be confiscated or destroyed.
- Do not bring unauthorized persons and children into the Conference Centre.
- Look after your valuable property.

Temporary importation of laptops and other workshop equipment

To comply with the import customs regulations of the Government of Zimbabwe, workshop participants should declare laptops and workshop equipment they may carry with them when entering the country.

Registration and identification badges

Participants will be required to register and obtain identification badges prior to the start of the session.

For security reasons, all participants are required to wear identification badges at all times, during the workshop as well as during official social functions.

Registration will start in morning of 23 October 2019. There will be a documentation and registration desk at the reception located at the Rainbow Towers Hotel & Conference Centre, where participants can register and receive an information package.

General information about Zimbabwe

Zimbabwe, officially, the Republic of Zimbabwe, is a landlocked country located in southern Africa, between the Zambezi and Limpopo Rivers, bordered by South Africa, Botswana, Zambia and Mozambique. The capital and largest city is Harare and the second largest being Bulawayo. A country of roughly 16 million people, Zimbabwe has 16 official languages, with English, Shona, and Ndebele the most commonly used.

Since the 11th century, present-day Zimbabwe has been the site of several organized states and kingdoms as well as a major route for migration and trade. The British South Africa Company of Cecil Rhodes first demarcated the present territory during the 1890s; it became









the self-governing British colony of Southern Rhodesia in 1923. In 1965, the conservative white minority government unilaterally declared independence as Rhodesia.

The state endured international isolation and a 15-year guerrilla war with black nationalist forces; this culminated in a peace agreement that established universal enfranchisement and de jure sovereignty as Zimbabwe in April 1980. Zimbabwe then joined the Commonwealth of Nations, from which it was suspended in 2002 for breaches of international law by its then-government, and from which it withdrew in December 2003. The sovereign state is a member of the United Nations, the Southern African Development Community (SADC), the African Union (AU), and the Common Market for Eastern and Southern Africa (COMESA). It was once known as the "Jewel of Africa" for its prosperity.

Climate

Zimbabwe has a tropical climate with many local variations. The southern areas are known for their heat and aridity, parts of the central plateau receive frost in winter, the Zambezi valley is also known for its extreme heat and the Eastern Highlands usually experience cool temperatures and the highest rainfall in the country. The country's rainy season generally runs from late October to March and the hot climate is moderated by increasing altitude.

Electricity

Electricity supply in Zimbabwe is 220-240 volts, 50 cycles AC accessible via 13-amp, three square pin (United Kingdom) socket. An image of this socket type is included below.
