(b) Subprogramme 6 — Gender and women in development

5. Parallel sessions

An analysis will be provided of the extent, nature and causes of informal employment and how it contributes to inequality in Africa.

(b) The demographic dividend in Africa: an entry point to implementing and monitoring the Addis Ababa Declaration on Population and Development
