The Ad Hoc Expert Group Meetings (AEGMs) will facilitate brainstorming by regional experts in smaller groups. In each case, studies will be presented and presentations be made by regional experts, and subsequently, participants will debate, with the objective of defining some actionable policy recommendations. Each group will select a rapporteur, who will present the findings to the ICSOE on Day 3 of the meeting.

Parallel Session I: "Promoting Regional Trade for Faster Job Creation"

Eastern African countries have made significant progress in economic development in the last decade. However, employment creation has remained a persistent challenge. In Ethiopia, for instance, the labour force is currently growing by more than 2 million people per annum, while in the DRC, Tanzania, Kenya and Uganda the labour force is increasing by 1 million people. Regionally, this requires the creation of half a million new jobs every month. This session will discuss this major social and economic challenge, and put forward proposals to tacke the problem particularly in the context of the AfCFTA. Several key questions will be addressed:

- a) How has the pattern of economic growth in Eastern Africa shaped job creation?
- b) What do studies reveal about the impact of regional trade on employment creation?
- c) What policy measures can be implemented to maximise the job creation potential of the AfCFTA?
