**Short Biographies of Presenters** 

#### **Prof. Parfait Eloundou-Enyegue**



#### **Professor, Department of Global Development, Cornell University**

Parfait Martial Eloundou-Enyegue's research agenda broadly addresses the interrelationships between population, social change, and sustainable development. Under this general theme, his current projects study the effects of today's demographic changes on global inequality, education, youth employment, health, food security, and internal conflicts. Parfait's methodological work advances the use of decomposition methods to reconcile micro and macro-traditions in quantitative sociological research

and to understand the sources of social change.

Before coming to Cornell, he was affiliated with the RAND Corporation (Los Angeles) and obtained a Doctorate Degree in Demography and Sociology from the Pennsylvania State University and an Advanced Degree in Agricultural Economics and Development Sociology from Cameroon. He has taught across multiple continents; mostly Africa, North America, and Asia, and has extensive experience with field research and policy communication. He has won teaching and prestigious research awards from the Population Association of America and the Comparative International Education Society. He also received the 2020 Distinguished Alumni Awards from the College of Agriculture at the Pennsylvania State University. Between 2008 and 2017, and with support from the Hewlett Foundation and the International Union for the Scientific Study of Population, he led a large effort to advance demographic training in Francophone Africa, including the study of Demographic Dividends. He has consulted with the United Nations, the World Bank, and USAID, and has worked on the Board of Directors of several professional associations and institutions including the Population Association of America, the Population Reference Bureau, the Guttmacher Institute, and the International Union for the Scientific Study of Population. He recently was a member of an independent group of 15 scientists nominated by the UN's Secretary-General Panel to draft the first quadrennial report on Sustainable Development Goals.

#### **Dr. Simeon Koffi**

Dr. Simeon Koffi is Head of the Research and Development Division of the ECOWAS Commission since 2008. Before that, he worked as a researcher at the Central Bank of West African States (BCEAO) and at the Ivorian Center for Economic and Social Research (CIRES), particularly in the Economic Policy Analysis Unit (CAPEC). He provided technical

support to Ministers in Côte d'Ivoire, especially in monitoring and evaluating national policies.

Dr. Simeon Koffi was also a lecturer in Economics, Statistics, and Econometrics at FHB University and the National School of Statistics and Applied Economics (ENSEA) of Abidjan. His current job consists of formulating and coordinating regional programs and projects, particularly the implementation of the ECOWAS Research Policy. In this regard, he prepares, in collaboration with national and regional stakeholders, various reports on the ECOWAS economy and the

regional integration process, and works in developing simulation and forecasting tools for the region.

Before occupying this position, Sib headed the Research Assessment and Monitoring Unit in various countries including DRC, Chad, and Burkina Faso since July 2009. He has spearheaded multiple studies for evidence-based programs on the emergency as well as for long-term hunger solutions.

Before joining the WFP, Sib served as Head of Mission for Caritas, France (2008-2009) and as Director associated with a research firm in Côte d'Ivoire and Morocco from 2003 to 2008. In his career, Sib has provided institutional support to shape strategic partnerships and to develop a food security policy, including strategic documents in the countries he has served. Sib is an Agricultural Economist and holds a Master's Degree in International Trade and Emerging Economy.

Trained in Sociology, Economics, and Political Sciences in Paris, Prof. Charbit got a Doctorat d'Etat ès-Lettres from Sorbonne in 1986 and a PhD from Oxford University in 1972, both summa cum laude. He is currently Professor Emeritus of Demography and Development at the University of Paris (2014-) and Associate Senior Research Fellow at Oxford University (2013- what?).

In 1989, he created and headed a large research unit called Centre Population et Développement (40 permanent researchers and faculties, 54 PhD students, several associates). He published the peer-reviewed Revue Européenne des Migrations Internationales in two series. The French series titled Populations (L'Harmattan Paris, 1995- ...; 44 books) and the English, Demographic Transformation and Socio-Economic Development (Springer, Dordrecht, 2011- ...; 12 books). Prof. Charbit was a Senior Expert and PI in numerous specialized domains in several African, South Asian, and Caribbean countries. These specialized domains are: (i) design and management of multi-bilaterally funded research projects in the field of population and development; (ii) design and implementation of training programs; and (iii) evaluation of national population policies.

#### **Prof. Eugenia Amporfu**

She holds a PhD in Economics from Simon Fraser University, Burnaby, Canada. She teaches Health Economics, Econometrics, and Advanced Microeconomics, both at the graduate and undergraduate levels. He worked with a team to produce a National Migration Policy and a strategic plan for Ghana (2012-2014). # Director of the ECA Sub-Regional Office for West Africa (SRO-WA), based in Niamey, Niger, covering 15 West African countries

Mrs. Ngone DIOP is an Economist, a Policy Development Expert, a Gender and Economics Expert with over 20 years of experience with a proven track record in results-based policy formulation and advice on poverty reduction, inclusive development, gender equality and the

empowerment of women, and demographic dividend.

Before she was appointed Director of ECA SRO-WA, Mrs. Diop was Chief of Gender Equality and Women's Empowerment at ECA, during which she led the formulation and implementation of innovative tools, policy researches, and results-based tailored advisory services to the African Member States.

Prior to joining ECA, she served as The UK Department of International Development Senior Advisor to the Government of Rwanda, after the genocide. During this time, she led the conceptualization and effective implementation of transformative policies and programs for Rwanda's socio-economic reconstruction; gender equality and women's empowerment, which have been recognized by the Government as an enormous contribution to Rwanda's transformative results, particularly on gender equality.

While heading the Poverty, Growth and MDGs work at UNDP, New York, Mrs. Diop spearheaded innovative policy work on economic growth, development, and inequality as well as the nexus between this trilogy and the achievement of the Millennium Development Goals (MDGs) with technical support and capacity building components that benefitted 56 countries, the majority of which were African.

Mrs. Diop served as Regional Technical Advisor of the World Bank Public Finance, Gender Budgeting Outreach Program for West and Central Africa. Her other major positions include researcher, economic analyst, and Lecturer in Economics at the Institute of Economics and Management in Dakar, Senegal. She also served as Course Director for Gender and Economics at IDEP.

Her publications are based on gender budgeting and public finance in the Commonwealth and IDRC. She published a book titled "Gender Budgeting Makes More Cents" with the Commonwealth, the Zed book called "Women and Land in Africa Culture; Rights and Realizing Women's Rights" with Emory University, USA.
