1. Opening Session

The 22nd Meeting of the Intergovernmental Committee of Senior officials and Experts (ICE) will begin proceedings on Wednesday, 8 May 2019 at 9:00 am at the Farmington Hotel in Robertsfield. Speeches will be made on this occasion.

2. Election of the Bureau

The outgoing President will invite the Committee to elect the new Bureau, composed of a Chairperson, a Vice-Chairperson and a Rapporteur.

3. Adoption of the Agenda and the Programme of Work

The Committee will be invited to adopt the Agenda and Programme of Work of the Meeting.

4. Social and economic development in Africa and in the world in 2018 and the outlook in 2019 for West African economies (*Preliminary session*)

ECA will share with the experts of West Africa (including Africa and World) Economics Majors trend for 2018 and 2019 outlook.

5. Review of statutory reports

a. Report on the implementation of the ECA SRO-WA Programme of Work for 2018 and the programme of work for 2019

The ECA will report to the Committee on the achievements of the Office during the period July 2018 to May 2019.

The Secretariat will make a presentation on the Liberia STEPS profile. This session will be open to the media.
